

RESOLUTION NO. 2301

A RESOLUTION OF THE CITY OF HARDIN, MONTANA ASSESSING THE COST OF STREET MAINTENANCE IN STREET MAINTENANCE DISTRICT NUMBER 1, FOR FISCAL YEAR 2022/2023.

WHEREAS, pursuant to its authority under Mont. Code Ann. § 7-12-4404 (2021), and Hardin Municipal Code § 9-5-1, maintenance in the street maintenance district is provided by contract or by forces employed by the City, or both; and

WHEREAS, pursuant to its authority under Mont. Code Ann. § 7-12-4422(2)(a) (2021), and Hardin Municipal Code § 9-5-2, the cost of street maintenance in said street maintenance district shall be levied and assessed on each lot or parcel of land within such districts for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, avenues, alleys and public places as set forth in this Resolution; and

WHEREAS, pursuant to its authority under Mont. Code Ann. § 7-12-4425(1) (2021), the City Council shall estimate, as near as practicable, the cost of maintenance in each established district annually, not later than the second Monday in August; and

WHEREAS, pursuant to its authority under Mont. Code Ann. § 7-12-4425(1) (2021), the City Council shall pass and finally adopt a resolution specifying the district assessment option and levying and assessing all the property within the district with an amount equal to not less than 75% of the entire cost of said work; and

WHEREAS, pursuant to its authority under Mont. Code Ann. § 7-12-4425(2) (2021), the resolution levying the assessment to defray the cost of maintenance shall contain or refer to a list of the lots or parcels of land assessed, with the name of the owner thereof, and the amount levied thereon set opposite;

WHEREAS, the assessment for 2022 for all non-agricultural property as determined by the State of Montana Assessor's Office has been determined to be 0.010407 dollars per square foot for each non-agricultural lot or tract up to ten acres and 0.0053 dollars for each square foot in excess of ten acres, with a maximum assessment of Three Hundred Thirty-One Dollars and Twelve cents (\$331.12) on any residential lot or tract, as classified by the State of Montana Assessor's Office; and

WHEREAS, the assessment for 2022 for all agricultural property as determined by the State of Montana Assessor's Office has been determined to be \$4.6347 per acre.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF HARDIN, MONTANA, as follows:

1. That the cost of sweeping and maintenance of the streets and avenues in Street Maintenance District No. 1 in said City, including the cost of sweeping parks, public places, the intersections of streets and alleys, be assessed at Four Hundred Fifty-Four Thousand, Seventy-Nine Dollars (\$454,079) for the 2022 tax year.
2. That the total cost of the assessment for the 2021 tax year be assessed against each and every lot or parcel of land in Street Maintenance District No. 1 shall be 75% of the estimated cost which is Three Hundred Forty Thousand, Five Hundred Fifty-Nine Dollars and Thirty-Two cents (\$340,559.32) according to the following:
 - a. All non-agricultural property as determined by the State of Montana Assessor's Office has been determined to be 0.010407 dollars per square foot for each non-agricultural lot or tract up to ten acres and 0.0053 dollars for each square foot in excess of ten acres, with a maximum assessment of Three Hundred Thirty-One Dollars and Twelve Cents (\$331.12) on any residential lot or tract, as classified by the State of Montana Assessor's Office; and
 - b. All agricultural property as determined by the State of Montana Assessor's Office has been determined to be \$4.6347 per acre.
3. That the City Finance Officer shall prepare a list containing the description of each lot or parcel of land, the name of the owner if known, and the amount of the assessment against each lot or parcel of land for the 2022 tax year, and said list shall be incorporated herein by reference and attached hereto as Exhibit A.
4. That said assessment for each lot or parcel in Street Maintenance District No. 1 shall be placed on the 2022 tax roll and shall be collected in two installments in the same manner as other taxes.
5. That all money collected in accordance herewith shall be credited by the City Finance Officer to the Street Maintenance District No.1 Fund.
6. That the installments shall become delinquent at 5:00 p.m. on the 30th day of November, 2022 and 5:00 p.m. on the 31st day of May, 2023, when such payments are due and payable.
7. That if an assessment becomes delinquent, the property shall be sold in the same process and procedure that other property is sold for delinquent unpaid taxes. The monies collected under this resolution shall be paid into the Street Maintenance Fund for the City of Hardin, Montana.
8. That the City Council of the City of Hardin Montana, pursuant to its authority under Mont. Code Ann. § 7-12-4425(1) (2021), estimated, as near as practicable,

the cost of maintenance in this established district at its regular meeting August 2, 2022.

9. That on the 2nd day of August at 6:15 p.m., in the Council Chambers of the City of Hardin, Montana or via virtual meeting room duly noticed; the City Council heard objections to the final passage of this resolution.

10. That upon final passage and approval of this resolution, the City Clerk is directed to certify a copy of said resolution to the Treasurer of Big Horn County and the Montana Department of Revenue, Big Horn County Field Office.
