**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HARDIN, MONTANA, OF
INTENT TO CREATE A NEW LIGHTING DISTRICT FOR THE CITY OF HARDIN
TO BE KNOWN AS LIGHTING DISTRICT #1 WHICH COMBINES LIGHTING
DISTRICTS #33 and #46**

WHEREAS, pursuant to its authority under Mont. Code Ann. § 7-12-4302 the City of Hardin desires to create a new lighting district for the City of Hardin;

WHEREAS, the City Council believes that it is in the best interest of the City as a whole and that the most cost effective and fairest assessment is to combine current lighting districts #33 and #46 into one new lighting district within the city limits of Hardin to be known as Lighting District #1; and

WHEREAS, the City Council desires to include the property shown on the map attached hereto as Exhibit A to this Resolution into one lighting district;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF HARDIN, MONTANA, as follows:

That the City of Hardin intends to created Lighting District #1 which will have the boundaries shown on the map attached hereto as Exhibit A. The proposed Lighting District #1 will contain all of the street lights currently contained in lighting districts #33 and #46. The approximate cost of the new lighting district will be \$19,550.00 for the maintenance of the lights and structures and for supplying electrical current for the lights. The entire estimated cost will be assessed against the property owners in the new lighting district.

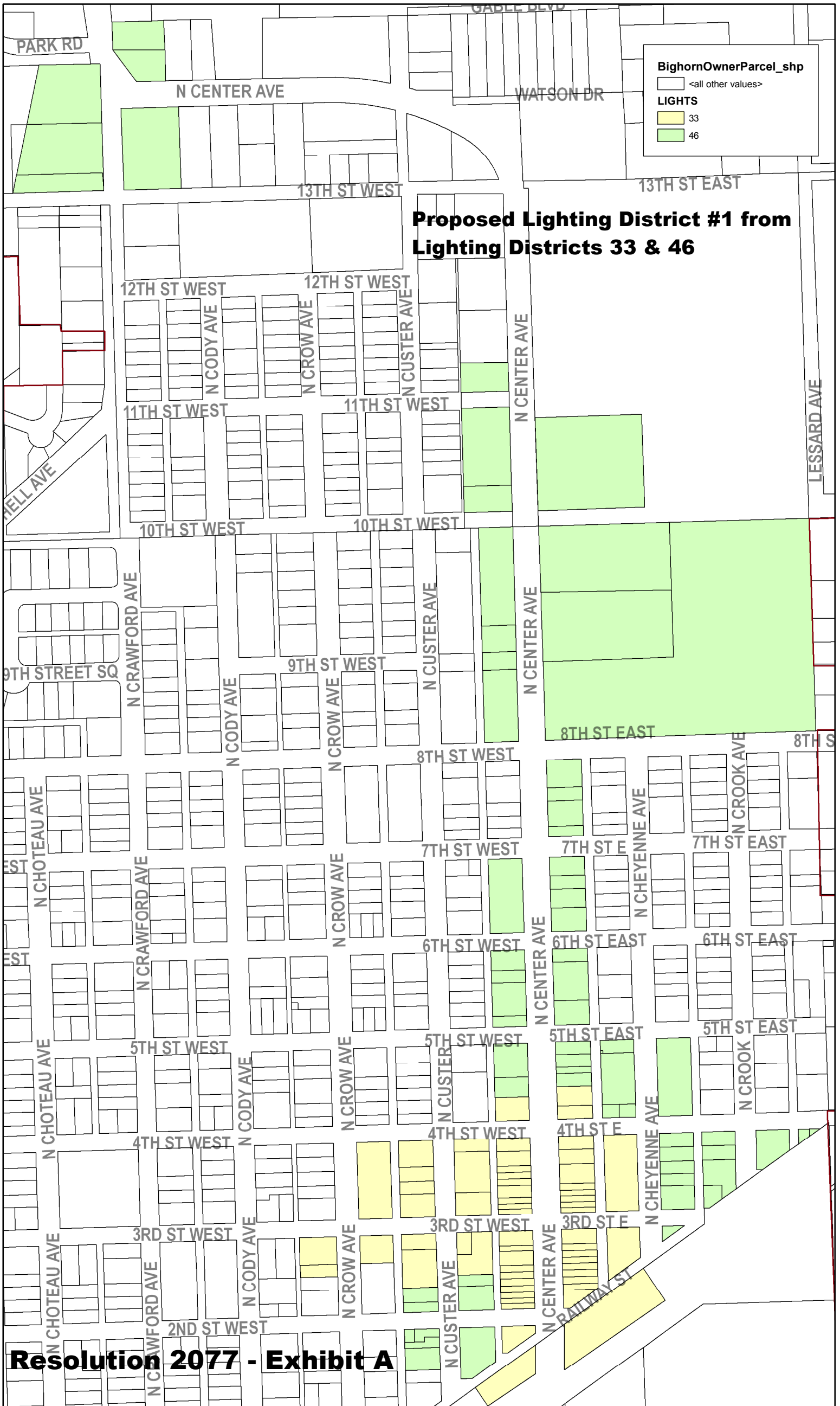
